Please read and initial that you understand and agree:

Tuition/Fees:

- _____ Non-refundable registration fee of \$30 per student or \$40 for families.
- _____ Classes are a flat monthly rate and run 9 months; September thru June. Students are enrolled in classes through the end of the year. Students are to pay full tuition every month including the last month of June. Classes are not pro-rated for missed classes.
- _____ Tuition and fees are non-refundable for any reason unless there is a class cancellation and no make up classes are available. TUITION PAYMENT BY CHECK/CASH IS DUE ON THE LAST CLASS OF THE MONTH. There is a \$10.00 late fee if tuition is not received by the 1st of each month. There is a \$10 credit card decline fee.
- _____ Recital Fee is due February 25th, 2011 in the amount of \$25 per family. This amount will automatically be charged for our autopay families.
- _____ “Tumbling Equipment Fee” is due annually in the amount of \$25 per family for all tumbling and cheer classes. This amount will automatically be charged for our autopay families.
- _____ Our office will assume you are still enrolled in classes and you will be billed unless the office is notified 30 days in advance, in writing.

Costumes:

- _____ Spring Recital Dance Costumes will be ordered for each group. Please Note: ½ Costume deposit due **October 25th** with balance due in full by **November 25th**. Costume Fees are \$50 for Child Small/Medium sizes and \$70 for Child Large & Adult Sizes. Your dancer will need a costume for each class he or she is performing with and will not be ordered unless fees are paid. Add'l fees due for XL sizes. This amount will automatically be charged for our autopay families.

Studio Etiquette and Policies:

- _____ Students may be dropped off no more than 10 minutes before their scheduled class and be picked up promptly at the end of class. Encore does not provide supervision while students are not in class. It is the Parents responsibility to watch the bulletin board and check email weekly for up coming events and information.
- _____ Only appropriate shoes and clean dancewear will be worn in classes. NO street shoes are allowed on the dance floor. Hair must be tied neatly away from face and in a bun for all ballet classes. Please refer to your class dress code.
- _____ Students are welcome to enjoy the grassy area at the Gearhart studio, if supervised by an adult at all times. Absolutely NO throwing of rocks or running through the parking lot. Cars are not always on alert for our little ones.
- _____ If Seaside School district classes are cancelled due to weather, Gearhart studio will also be cancelled and make up classes will be scheduled. If Warrenton/Astoria School district closes due to weather, the Warrenton will also be cancelled and make up classes will be scheduled
- _____ Observation and “Dress Up” Day (for our little ones!) is scheduled for the last class of the month. All classes will be closed to observers except the last class of the month.
